

Dear Mayor Marine, Mukilteo City Council Members and Citizens of Mukilteo, 2012 was a year of transition that saw major and minor changes around the department. Below is a partial list of some of the highlights of our Public Safety efforts.

Grants brought over \$30, 000 worth of equipment and additional overtime coverage for traffic safety projects such as Click or Ticket and Target Zero Teams DUI emphasis. As technology has improved, the agency has struggled to keep with the times, however we successfully tested and are installing updated computers in the patrol vehicles to better serve our citizens.

Staffing challenges plagued the agency during 2012 with as many as five staff members unavailable due to illness and injury. Retirement of two long time employees required the first hiring process in many years creating a great deal of interest in applicants to become future officers. On a brighter note, the staff also welcomed the birth of two children from officers and we were authorized to add a half-time employee to the Support Services staff – the first such increase since 1996.

With the discontinuation of the iconic Ford Crown Victoria police car, the department has moved to the newly designed Ford Interceptor line. With updated graphics on a black and white paint scheme, the new vehicles are safer and more fuel efficient for added savings to the public.

Completion of facilities upgrades to include additional site security for our staff, removal of surplus materials, disposal of a decade's worth of old records and removal of others to secure storage on-site.

Partnerships with the community continue in the form of internships with a local community college, school safety presentations with Mukilteo School District and presentation of Citizens Academy and National Night Out events.

The department continues to focus on training our staff as instructors and in building expertise. Officers became instructors in a variety of areas including Emergency Vehicle Operation, Defensive Tactics, Standardized Field Sobriety Testing and SECTOR.

The Mukilteo Police Department staff remains dedicated and enthusiastic looking forward to bringing new members aboard as 2013 progresses.



ADMINISTRATIVE DIVISION

Overall highlights of efforts within the Administrative Division during 2012 include:

- An audit of the evidence room was conducted by an outside agency.
- Built upon a resource library available to all staff members consisting of leadership, management, and supervisory books, compact discs, and DVDs.
- Sought and obtained grants for training and equipment from a variety of sources.
- Numerous outreach efforts to the community further described throughout this annual report.
- Brought the department budget in under projections.

GOALS AND OBJECTIVES

The 2012 Police Department goals and objectives as well as progress in attaining them are outlined in attachment ^{A-2}.

PATROL DIVISION

The Patrol Division is the largest and most visible representation of the day-to-day operations of the Police Department. This Division provides highly visible uniformed patrol response 24 hours a day 7 days a week, year round.

Authorized Staffing for the Patrol Division for 2012 was twenty-one commissioned Police Officers, but only twenty positions were fielded on the street. Six different Officers took either maternity leave, sick leave, or worked light duty because of injuries that equaled more than one full-time equivalent position.

Activity measures include calls-for-service, traffic enforcement and crime. The total calls for service handled by the Police Department in 2012 decreased from 2011. Those numbers were **12,866** and **15,128** calls respectively. A chart of all dispatched calls from 2010 through 2012 is attached as ^{A-3}. An analysis of traffic enforcement by the department is in the next section of this report.

Mukilteo continued a downward trend in the overall crime rate with a significant reduction in the overall 2012 crime rate compared to 2011. Further scrutiny of



reported crime is contained in the "UNIFORM CRIME REPORTS" section of this annual report.

Almost every day, every patrol squad provided extra patrol in the north-end portion of the city covering both the Lighthouse Park as well as the decommissioned Air Force Tank Farm.

In January Corporal Bredstrand and Officer Mittelbach received the Life Saving Award after they rescued a suicidal man off the railroad tracks after he had stabbed himself.

In January Corporal Bredstrand and Officers Sanchez, Becker, and Hamilton received letters of commendation for their work with a mentally ill subject that threatened to bomb the ferry system.

TRAFFIC

Traffic enforcement accomplishments for 2012

- Completed installation and training for electronic ticketing scanners/printers (SECTOR) in all patrol cars from a 2010 equipment grant from the Washington Association of Sheriffs and Police Chiefs.
- The Police Department continued the partnership with "Target Zero Teams DUI/Traffic Task Force" and received \$8,000 in overtime reimbursement grants to provide traffic enforcement
- The department obtained two additional electronic portable breath test (PBT) devices through grants received from the Washington State Traffic Safety Council. This brings our total number of PBTs in the department to nine.
- No fatal traffic collisions occurred in Mukilteo in 2012. There were three fatal collisions in 2007, and one in each of 2008, 2009, and 2010.

SPECIAL OPERATIONS DIVISION

During 2012 the Special Operations Division had an authorized staffing of two Detectives dedicated to investigations and one Sergeant providing 1st level supervision. The Sergeant also oversees all case reports prepared within the Department in order to prioritize and investigate criminal activity. The Division Sergeant is the Agency Representative/Coordinator for the Western States Information Network, the Law Enforcement Information Exchange System, and



the Law Enforcement Notification System for Federal Offenders on Probation that reside in the City of Mukilteo.

Some of the Division responsibilities include providing assistance and support to the patrol division, handling lengthy and/or complicated investigations that require special attention, investigating Child Protective Services (CPS) referrals, Adult Protective Services (APS) referrals, monitoring the registered sex offenders within the City of Mukilteo, background investigations for police officer applicants, as well as a wide variety of other tasks.

The Division still participates in the Snohomish County Multiple Agency Response Team (SMART) as well as the Regional Intelligence Group (RIG) and works very closely with the Snohomish County Prosecutor's Office as well as the City of Mukilteo Prosecutor's Office.

Some notable cases investigated by the Special Operations Division in 2012 include:


Arrest of four adult males who had committed a home invasion robbery. The resident in the home was assaulted and shots were fired inside the residence and also fired at the residence as the suspects were fleeing in a vehicle. A search warrant was served on the suspect vehicle. A handgun and marijuana was recovered from the vehicle. All four suspects plead guilty and were sentenced to prison.

Kidnapping/Unlawful Imprisonment case that resulted in a vehicle pursuit and an arrest of the primary suspect. Illegal Narcotics were located and a search warrant was served at the apartment where the crime occurred. The suspect was sentenced to a prison term.

A serious Child Abuse case investigated by the division in 2011 finally went to trial in 2012. After a two week trial a jury found the female suspect guilty on counts of Assault of a Child, Criminal Mistreatment of a Child, and Tampering with a Witness. She was sentenced to 30 years in prison. The male suspect in the case was recently charged and is awaiting trial.



Eighty-three cases were still being worked on in investigations that had been held over from 2011. 162 cases were assigned out for investigation during 2012. Of the total 245 cases worked on in 2012, 90 were closed by either



arrest, referral to prosecution, or due to extenuating circumstance s such as victims failing to cooperate or

the reported crime did not occur. 85 cases were placed in a suspended status with no additional leads to follow, and 70 cases were held over for further investigation in 2013.

COMMUNITY SERVICE OFFICER

The Mukilteo Police Department has one Community Service Officer (CSO). This position has three major responsibilities. ①Animal Control, ②Parking Enforcement, and to ③Assist in Support Services. The Community Service Officer is a civilian position supervised by the Commander.

In 2012 the Community Service Officer adjusted her scheduled work hours and days to address parking issues that occur during the summer months at Lighthouse Park. The schedule change lasted from May until September and helped to maintain parking controls in Lighthouse Park.

ANIMAL CONTROL

The number of Animal Calls in 2012 (434) was level with 2011 (424.)

The City of Mukilteo contracts with the Progressive Animal Welfare Society (PAWS) to provide sheltering services. The shelter statistics from PAWS showed a decrease in the number of animals taken into their facility from our city. In total 87 different cats (43) and dogs (44) were brought into the shelter either by the Community Service Officer, or by residents of Mukilteo.



The disposition of impounded animals through the PAWS shelter is detailed in the following chart:

SUPPORT SERVICES DIVISION

In 2012 Support Services continued its maintenance program for the front office by preparing 20 bins of old case files for shredding through Datasite Shredding. Included in this Records Management was the further development of the Archives in the basement area to alleviate the overcrowding upstairs in Records and avoid further costs connected with storage off-site. Support Services completed an Independent Evidence Room Audit.

The division processed \$472,718 in fines and bail forfeiture during 2012. The new SECTOR program and the account with Elliott Bay Adjustment Company (to pursue collections of old parking tickets) have made a strong difference in the quantity of tickets written and monies collected. In addition public disclosure requests and Concealed Pistol Licenses were both increased from last year. A Support Services Activity Comparison Report is attached as ^{A-4}.

A worksheet detailing a three year comparison of Citations, Infractions and Jail Bookings is also attached ^{A-5}.

TRAINING

Training hours for department members decreased slightly in 2012 from the previous year. The total of 2,592 hours represents a 12½% decrease from 2011 (2,964) training hour totals.

Highlights of 2012 training include having an instructor certified by the Washington State Criminal Justice Commission to teach Defensive Tactics. He joins two other Defensive Tactics instructors already on staff.

The department again conducted two range qualification/trainings in 2012, and incorporated defensive tactics into the training.

UNIFORM CRIME REPORTS


Analysis of the City of Mukilteo Uniform Crime Reports shows a decrease of 21% in overall reported crime. This includes an increase in Forcible Rape (100%,) decrease in Simple Assault (-20%,) and decrease in Aggravated Assault (-20%.)
